



MOLDOVAN ACCESSION

Background

Moldovan accession to the STCU was completed in December with the receipt of the European Council decision to approve Moldova's membership. Now there is a necessity to send our STCU Management representatives to Moldova to re-establish ties with the Moldova Government because of the recent reorganization process in the Moldova Government, especially with the previously named (but now reorganized) Supreme Council for Science and Technology.

Also we require re-establishing relations due to the rather long delay which has occurred since our last meetings back in 2003 and in February 2004. This is particularly important because there are new Moldovan officials that the STCU is anxious to engage, such as Mr. Gheorghe Duca, the President of the Academy of Sciences in Moldova. There also are upcoming parliamentary elections in February which could usher in new Moldovan officials throughout the Moldovan government, therefore several STCU visits will be necessary to establish relations with all of these new people.

Additionally, the Moldovan candidate for the STCU Regional Officer position decided to accept another job offer, and the proposed location for the Regional Office was lost due to the relocation of Supreme Council of S&T Development, which had agreed to host the STCU Regional Office. Therefore, the STCU has engaged in a new round of candidate selection for the Regional Officer position and a new search for suitable premises for the Regional Office. The planned trips by STCU management will settle these issues as well as all other issues necessary to begin STCU operations in Moldova.

I would like to note that almost every day we receive calls from Moldovan scientists willing to send their proposals to the STCU. At the moment we are only able to provide them with information on STCU activities. There are already a couple of unofficial "Short Form Proposals" received by the STCU from Moldovan scientists, but there is no clear indication that these proposals have received approval from the Moldovan government. Establishing what Moldovan agencies have authority to grant Host Government Concurrence on STCU proposals will be another task during the next few months.

The STCU is ready to start to move forward to establish the office in Moldova. Funds for that are budgeted in the STCU 2005 budget proposal including funds for establishing the office itself, office budget including training of new Regional Officer, travels needed, and Grant Writing Workshop for Moldovan scientists. Correspondence between Moldova and the STCU, as well as a draft schedule of tasks for establishing STCU operations in Moldova, is attached to this report.

I am pleased to inform your government of the final and full accession of the Government of Moldova to the Agreement to Establish the Science and Technology Certer in Ukraine (STCU). On 22 November 2004, the STCU received notice from our representatives of the European Union that the European Council had adopted the recommendation to approval Moldova's accession as a beneficiary Party to the STCU. This was the final step necessary to complete the process of approval by the STCU Governing Board.

The STCU has in its possession an instrument of ratification dated 16 January 2004. With the final approval of the STCU Governing Board and this instrument of ratification, the Republic of Moldova has completed all the necessary steps for full participation in STCU projects and activities.

The next step is to establish an STCU regional office in Chisinau and complete the formalities to allow the STCU to operate in Moldova according to the requirements in our STCU Establishing Agreement and Statute. These formalities include establishing diplomatic accreditation for the STCU regional office and STCU executive staff, stablishing legal status for tax exemption and customs duty exemptions for STCU financial and procurement transactions, and establishing agreements with Moldovan banks to conduct STCU financial transactions inside Moldova.

The STCU staff will begin immediately to work with the appropriate Moldovan officials to establish STCU operations in your country.

On behalf of the STCU and its Governing Board, I wish to express my congratulations on Moldovan accession to the STCU. We all look forward to working with the Moldovan scientific community and the Moldovan government to develop excellent science projects, expand the network of cooperative science work with the international science community, and establish advanced, self-sustainable S&T research capabilities for former weapons scientists and their institutes in Moldova.

I would like to inform you, that according to the LAW OF THE REPUBLIC OF MOLDOVA, Code of the Republic of Moldova on Science and Innovation, No 259-XV dated 15.07.2004, the Academy of Sciences of Moldova is the unique public institution of national interest in the area of science and innovation, the plenipotentiary coordinator of scientific and innovation activities, is the highest scientific forum of the country and scientific consultant of public authorities.

This code regulates legal relations, connected with elaboration and implementation of the state policy in the field of science and innovations, activity in the field of scientific researches, innovations and transfer of technologies, scientific-technological information, accreditation of organizations in the field of science and innovations, attestation of scientific and scientific-pedagogical personnel of highest qualification, protection of intellectual property, legal status of entities in the field of science and innovations.

The Government enters with the Academy of Sciences into Partnership agreement, on the basis of which the Academy of Sciences is delegated the powers to carry out the state policy in the field of science and innovations and to determine the strategy of development of science and innovation activity.

Taking in consideration the above mentioned, the Academy of Sciences of Moldova is very interested in the opening of a STCU Office in Moldova.

I would be very grateful to you, if you keep informing me of all the steps taken in this matter.
